## PRESS RELEASE - January 25, 2017

- Misdemeanor - DUI (1st offense - BAC unknown), and Chemical Test Refusal:**  
On Saturday, January 21, 2017 at approximately 1:50 AM, Patrolman Michael Jacome arrested **Ryan Landry**, age 41, of 233 Chaplin Drive, Coventry on a charge of (1) **Driving Under the Influence of Alcohol and/ or Drugs (1st offense - BAC unknown)**, and (2) **Refusal to Submit to a Chemical Test (civil)**, after monitoring a police radio broadcast of an erratic operator traveling south on Route 3 in West Greenwich. Off. Jacome observed the vehicle on Nooseneck Hill Road in Richmond and eventually stopped the vehicle on Route 95 Southbound. Mr. Landry was arrested on suspicion of DUI after performing a series of standard field sobriety tests. He was processed at the station, where he refused to consent to a chemical test. Mr. Landry was arraigned before Justice of the Peace Michael Robinson, and was released with a summons to appear in 4<sup>th</sup> District Court for arraignment on February 16, 2017, for the above DUI charge.
- Misdemeanor - DUI (1st offense - BAC .08 - .10):** On Sunday, January 22, 2017, at approximately 3:45 AM, Patrolmen Brock Taylor and Jeffrey Vaughn arrested **Shane D. Drake**, age 41, of 516 Carolina Back Road, Charlestown on a charge of **Driving Under the Influence of Alcohol and/ or Drugs (1st offense - BAC .10-.15)**, after a motorist reported a vehicle partially off the road in the area of 335 Church Street in Alton. Officers arrived to find Mr. Drake stopped diagonally facing the wrong direction in the opposite lane of travel, with his vehicle's engine running. Ms. Drake was arrested on suspicion of DUI after performing a series of standard field sobriety tests. He submitted to a Breathalyzer test that resulted in BAC (blood-alcohol-content) readings of **.085 (1st phase)**, and **.088 (2nd phase)**. He was processed at the station, and was released with a summons to appear in 4<sup>th</sup> District Court for arraignment on the above charge.
- Misdemeanor - Operating on Suspended License (3rd Offense):** On Monday, January 23, 2017, at 8:35 PM, Patrolman Ryan Donohue arrested **John E. Finck**, age 37, of 111 Conanicus Road, Narragansett on a charge of **Operating on a Suspended License (3rd suspended license violation)**, after a motor vehicle stop on Rose Lane (off Shannock Hill) revealed that his license had been suspended on July 12, 2016 for *Failure to Appear/Pay*. Mr. Finck was processed at the station, and was released with a summons to appear in 4<sup>th</sup> District Court on February 23, 2017 for arraignment.

4. **Misdemeanor - Domestic Simple Assault and Domestic Disorderly Conduct:**  
On Monday, January 23, 2017 at approximately at 11:54 PM, Patrolmen Anthony Zoglio and Ryan Donohue arrested **Caitlin R. Peabody**, age 20, of 200 Shannock Village Road, Apt. 1-B, Richmond on charges of (1) **Domestic Simple Assault**, and (2) **Domestic Disorderly Conduct** after officers were dispatched to a reported domestic disturbance in progress at the above address. Upon arrival, investigation revealed that Ms. Peabody had allegedly lost control during a violent outburst in which she screamed and yelled at other members of the household, threw valuables that did not belong to her, and struck another member of the household with several closed-fist punches. She was processed at the station, and held overnight for arraignment in 4<sup>th</sup> District Court the next morning.
