PRESS RELEASE - July 12, 2017

Misdemeanor - Disorderly Conduct: On July 06, 2017, at approximately 4:58 PM Patrolman Daniel Kelley and Patrolman Ryan Donohue arrested **Jamie T. Bruskie**, age 48, of 31 Knowles Lane, Richmond on a charge of **Disorderly Conduct** after police were called for a verbal confrontation related to a driving incident that occurred on Marvel Trail in Richmond. Mr. Bruskie was processed at the station and released on a summons to appear in 4th District Court on August 03, 2017 to be arraigned on the above charge.

Felony/Misdemeanor- Leaving the scene of an Accident with injury: On July 06, 2017 at 6:00 PM, Patrolman Daniel Kelly arrested **William J. Griffin**, age 21, of 289 Woodville Road, Hopkinton after he turned himself in at the Richmond Police station. He was arraigned on two felony charges of (1) **Leaving The Scene Of An Accident with Personal Injury** and (2) **Driving As To Endanger Personal Injury Resulting**, as well as misdemeanor charges of (1) **Disorderly Conduct** and (2) **Reckless Driving**.

The charges stem from a 911 call to the Richmond Police station on June 19, 2017 at approximately 8:30 PM reporting an active road rage type incident on Old Mountain Trail which ended in a motor vehicle crash between two vehicles at the intersection of Hillsdale Road and Old Mountain Trail. Upon officer's arrival one of the involved vehicles was found on it's side. The second involved motor vehicle being operated by Mr. Griffin had fled from the scene of the crash. The two occupants of the overturned vehicle were treated for minor injuries.

Mr. Griffin was arraigned before Justice-Of-The-Peace Michael J. Robinson and was released on \$10,000.00 personal recognizance pending a felony screening date on the above charges.

Misdemeanor - Domestic Disorderly Conduct and Domestic Vandalism:

On July 06, 2017 at approximately 9:38 P.M. Patrolman Ryan Donohue and Patrolman Daniel Kelley arrested **Fortunato Cordeiro**, age 76, of 28 Old Mountain Trail, Richmond on charges of **Domestic Disorderly Conduct** and **Domestic**

Vandalism. Officers were dispatched to a 911 call of a domestic disturbance in progress at the above address. Mr. Cordeiro was taken into custody without incident and transported to the station where he was processed and arraigned on the above charges and released on personal recognizance with a promise to appear in 4th District Court on July 20, 2017 for re-arraignment.

Bench Warrant:

On July 09, 2017 at approximately 4:57 PM, Patrolman Anthony Zoglio arrested **Marc Michaud II**, age 30 of 119 Old Jewett City Road, Preston Ct
On the strength of an outstanding **Bench Warrant** for *Failure to Appear-cash owed* originating from a DUI first offense charge by the Hopkinton Police. Mr. Michaud was processed at the station and arraigned by Justice-of-The-Peace James Callaghan and released.
