## PRESS RELEASE - June 7, 2017

1. **Misdemeanor - Disorderly Conduct:** On Sunday, June 4, 2017 at 4:37 PM, Corporal William Litterio arrested **Peter T. Dugan**, age 51, of 7 Soneric Lane, Richmond on a charge of **Disorderly Conduct** when the officer was dispatched to that neighborhood after Mr. Dugan allegedly gestured profanely as he was delayed by a motorist who had stopped to speak with a neighbor. Mr. Dugan allegedly alighted from his vehicle after the neighbor commented on the hand gesture and allegedly uttered a profane statement in the presence of the neighbors and their young children before getting back into his car and driving away. He was processed at the station and was released with a summons to appear in 4<sup>th</sup> District Court on June 29<sup>th</sup>, 2017 for arraignment on the above charge.
2. **Wayward Juvenile - Disorderly Conduct:** On Sunday, June 4, 2017 at 5:01 PM, Patrolman Ryan Donohue arrested a **15-year-old female resident of Richmond** on a charge of **Disorderly Conduct** after the officer was dispatched to the youth's address when her parents called E-911 to report that she was out of control and damaging property in the home. The youth tore a curtain rod and curtains to the floor, and deliberately knocked a framed painting off the wall to the floor, and then aggressively pushed her parents. The youth was returned to the station and was subsequently released to the care of a separate family guardian. She shall be petitioned into Family Court on the above charges.
3. **Bench Warrant:** On Sunday June 4, at 8:51 PM, Corporal William Litterio and Patrolman Ryan Donohue arrested **Evan C. Harding**, age 22, of 2194 Narrow Lane, Charlestown on the strength of an **outstanding Superior Court Full Bench Warrant** that had been issued on May 18, 2017, for *Failure to Appear for Technical Violation* on an original charge of *Obtaining Money by False Pretenses and Larceny Under \$1,500* (Cranston PD) after a motor vehicle stop by Cpl. Litterio on Church Street in Alton. Mr. Harding was processed at the station, and was transported the Intake Service Center at the ACI.

4. **Bench Warrant:** On Monday, June 5, at 9:04 PM, Patrolman Ryan Donohue arrested **Ashleigh Edwards**, age 26, of 23 Richard Street, Apt. 1, Cranston on the strength of an **outstanding 3<sup>rd</sup> District Court Bench Warrant** that had been issued on December 8, 2015, for *Failure to Appear - Ability to Pay* on an original charge of *False Report of a Crime* (West Warwick PD) after the warrant was revealed when she visited the Richmond Police Department on an unrelated matter. Ms. Edwards was processed at the station, and was transported the Women's Intake Service Center at the ACI.
